IG AUSTRALIA PTY LTD REFER A FRIEND TERMS AND CONDITIONS

- 1. These terms and conditions ("**Rules**") apply to the Refer a Friend promotion ("**Promotion**"). By participating in the Promotion, you agree to be bound by these Rules.
- 2. To qualify for the Promotion, the person making the referral ("you") must:
 - (a) hold an active Share Trading account with IG Australia Pty Ltd (ABN 93 096 585 410, AFSL 515106, Derivatives issuer licence in New Zealand, NZBN 9429047618251, FSP No. 684919) Level 32, Queen & Collins, 376-390 Collins Street, Melbourne, VIC 3000. ("we","us", "IG" or "our"); and
 - (b) be an individual and a direct client of IG.
- 3. You must have an existing business or personal relationship with the individual you would like to refer ("Your Friend"). Your Friend must be an individual who is 18 years or older. - 7. If any restrictions apply to one of your accounts or an account of Your Friend, the referral will not qualify as an Active Referral until the restrictions have been lifted. Any restrictions that apply to an account will be notified to the account holder by email. The referral will not qualify as an Active Referral if any of your accounts or an account of Your Friend is closed for any reason.
- 8. Any trading credits awarded under the Promotion will be credited to your Share Trading account. For the avoidance of doubt, we will not credit trading credits to your CFD account.
- 9. Within 90 days of Your Friend becoming an Active Referral you will receive a trading credit credited to your IG Share Trading account calculated as set out below (each a "Refer a Friend Reward":
 - If Your Friend qualifies as an Active Referral in relation to a CFD account, you will receive a Refer a Friend Rewards in the value of AUD250;
 - If Your Friend qualifies as an Active Referral in relation to a Share Dealing account, you will receive a Refer a Friend Reward in the value of AUD50.

- 22. If any tax is payable on the Refer a Friend Reward paid by us to you pursuant to the Rules, this tax will be your liability and will not be incurred by us.
