ABSA

To make a payment, you'll need:

If you are registered for Absa Online, you can set up a SWIFT payment by logging in to your account, then clicking on 'international funds transfer' under the 'payments' tab.

To make a payment, you'll need:

- IG's bank details, account number, account name and address
- All documents required by the South African Reserve Bank (SARB)

STANDARD BANK

To make a payment, you'll need to visit your nearest branch with the following information:

- IG's name, address, and bank account details
- The IBAN number for the account you wish to fund
- All documents required by SARB

OR

Make an international payment on the latest updated Standard Bank transactional app.

OR

Download the Standard Bank GetShyft app, a global digital wallet for compatible with iOS and Android devices. You can use Shyft to buy funds in USD, EUR, GBP and AUD.

FNB

To make a payment, you'll need to:

- Login to your FNB online banking account and select 'forex'
- 2. Select 'global payments', then click 'add'
- 3. Choose the account you wish to make the payment from on the 'from account' pop up
- 4. Fill out all the payment details
- 5. Complete the recipient details
- 6. Indicate who the payment is being made on behalf of
- Confirm that all the details of the payment are correct, then select the 'certificate' and enter your password
- 8. Upload all relevant documentation for the payment
- 9. Hit 'finish'

NEDBANK

To fund your account, you'll need to:

- Download a form called the application for overseas transfer of Funds' from the Nedbank website or get one at your local Nedbank Forex branch
- 2. Fill in the form, and take it to your Nedbank Forex branch together with all supporting documentation to complete the transaction
