#### TERMS AND CONDITIONS REACTIVATION BONUS PROMOTION

The following Terms and Conditions ("Terms") apply to the IG US LLC ("IGUS") Reactivation Bonus Promotion (the "Promotion"). By participating in the Promotion, the participant agrees to be bound by these Terms. The start date ("Start Date") of the Promotion is November 15, 2021.

**1.** A participant will only be entitled to the reactivation bonus ("Bonus") if the eligibility requirements set forth herein are met.

## 2. Promotion eligibility requirements.

#### 3. Bonus.

- 3.1 Subject to the Section 5 of these Terms, participants who meet all eligibility requirements as set forth in Section 2 of these Terms will receive a \$50.00 Bonus.
- 3.2 IGUS endeavors to apply the Bonus to the participant's account by the fifth business day of the month following a participant's completion of all eligibility requirements.
- 3.3 Each participant who meets all eligibility requirements will be entitled to one (1) \$50.00 Bonus, regardless of the number of debit card accounts registered to the participant's account requiring verification.
- 3.4 Participants are not obligated to use the Bonus for trading at IGUS and may opt to withdraw the Bonus from the participant's IGUS account.

# 4. Termination of Promotion.

4.1 The Promotion will end at 11:59pm ET on November 30, 2021 ("End Date"). 5.1 A reactivation deposit which does not clear and/or is returned by IGUS's bank for any reason will not be considered successful, and the participant will be disqualified from the Promotion and forfeit the

### 7. Other Terms.

- 7.1 All dollar values described herein are USD.
- 7.2 All withdrawal requirements must be met before a withdrawal can be made.
- 7.3 Participant is responsible for all applicable taxes.
- 7.4 In the event a participant provides false or fraudulent information or documentation, notice of the alleged fraud may be provided to the appropriate financial, regulatory, or law enforcement agency.

- 7.8 If at any time all or any part of any provision of these Terms are or become illegal, invalid or unenforceable in any respect under the law of any jurisdiction, such provision(s) shall not affect or impair the legality, validity or enforceability in that jurisdiction of the remainder of that provision or all other provisions of these Terms or the legality, validity or enforceability under the law of any other jurisdiction of that provision or all other provisions of these Terms.
- 7.9 These Terms shall be governed by and construed in accordance with the laws of the State of Illinois.
