

## IG US New Account Bonus Terms and Conditions

1. These terms and conditions ("Rules") apply to the New Account Bonus promotion ("Promotion"). By participating in the Promotion, you agree to be bound by these Rules.
2. To be eligible for the Promotion, the person claiming the bonus ("you", "your") must:
  - a. be an individual who is 18 years or older;
  - b. be a United States resident (but not resident in Ohio); and
  - c. not hold an existing personal, joint or legal entity forex trading account with IG US LLC, a Commodity Futures Trading Commission (CFTC) registered retail foreign exchange dealer and member of the National Futures Association ("NFA") (NFA #0509630) with its primary address: 200 West Jackson Boulevard, Suite 1450, Chicago, IL 60606 and contact details: 1-312-981-0500 and helpdesk.us@ig.com ("we", "us", "IG" or "our");
3. To participate in the Promotion, you must:
  - a. sign up for a new IG account using the URL provided to you as part of this Promotion. Failure to sign-up for a new account using the correct URL will disqualify you from participating.
  - b. be approved for an IG account and complete all required documentation and identity checks.
4. To qualify for the Promotion, you are required to open and fund a new active personal forex trading account with IG through the Promotion URL and meet the requirements for either the Standard Bonus or the Premium Bonus as set forth in these Rules prior to the expiry date ("Qualifying Account"). Trades must be executed and confirmed by IG's platform.
5. The expiry date for the Promotion is March 31, 2022 at 11:59pm EST.

### **Standard Bonus**

6. A New Account Standard Bonus ("Standard Bonus") of \$250 will be paid into a Qualifying Account that has made a first deposit of at least the minimum deposit amount and executed at least one opening trade prior to the expiry date. Only one Standard Bonus will be paid per person. The minimum deposit amount in force at the time you open the account will be notified to you on the deposit funds screen.

### **Premium Bonus**

7. A New Account Premium Bonus ("Premium Bonus") of \$5,000 will be paid into a Qualifying Account that has made a first deposit of at least \$50,000<sup>1</sup> and executed opening trades that total at least 300 standard contracts, or lots, prior to the expiry date. These trades can be in any currency pairs offered by IG. Only one Premium Bonus will be paid per person.

### **Terms Applicable to the Both Standard Bonus and Premium Bonus**

8. The Standard Bonus and Premium Bonus are each a "Bonus" and collectively the "Bonuses".

IG is a trading name of IG US LLC (a company registered in Delaware under number 6570306).  
IG US LLC is a registered RFED and IB with the Commodities Futures Trading Commission and member of the National Futures Association (NFA ID 0509630).

9. When depositing from a debit card for the first time, for verification purposes a micro deposit of \$1.00 will be credited to your IG account. This micro deposit is **not** the minimum deposit amount required for purposes of this Promotion, nor is it considered your initial deposit. The minimum deposit amount required to qualify for the Promotion will be reflected on the deposit funds screen in your IG account.
10. For the purposes of calculating the required trade volume, only opening trades that have been executed and confirmed by IG will count towards the total. Unexecuted or rejected trades will not count, nor will closing trades.
11. Bonuses will be paid within approximately 45 days of meeting all requirements for either the Standard Bonus or the Premium Bonus.
11. If any restrictions apply to your account, the account will not qualify for a Bonus until the restrictions have been lifted. Any restrictions that apply to an account will be detailed in the email to you upon account activation. The account will not qualify for a Bonus if your account is closed for any reason prior to a Bonus being paid.
12. All accounts are subject to our standard account opening criteria and are subject to certain jurisdictional restrictions, therefore not all applicants will be successful in their application for an account.
13. Joint accounts or accounts which have a Power of Attorney in force will not be eligible for a Bonus.
14. In the event your first deposit is cancelled, clawed or charged back, returned from the bank for insufficient funds, fraud, or any other reason, you will become ineligible for a Bonus and IG has the right to reclaim and remove from your account any Bonus made to your account under this Promotion. In the event the removal of any Bonus paid to your account would result in a negative balance, the deficit amount may be submitted to IG's third party collection agency.
15. The Promotion is not open to employees of IG or any IG group company or employees of any other company engaged in direct competition with IG or any IG group company.
16. IG reserves the right to amend these Rules, alter the Bonus or substitute the Bonus offered with another item of the same value, at its sole discretion, from time to time and without prior notice to you.
17. The Promotion and any obligations of IG pursuant to it will be revoked or withdrawn from participants who abuse the spirit or intention of it. We reserve the right to cancel or withdraw the Promotion at any time in case of any suspected abuse of the Promotion. Further, where any of these Rules are breached, if we believe that any of the terms of your Customer Agreement with us have been breached in any way, or there is any reason to suspect a participant has acted fraudulently or obtained an unfair or unintended advantage pursuant to this Promotion, we reserve the right to stop, withhold or cancel payment of a Bonus or to prevent any attempted withdrawal of the same from your account.
18. We are the sole arbiter of the Promotion, these Rules and any other issues arising under this Promotion. Exceptions to these Rules are at the sole discretion of IG's management, and our

decision is final. We reserve the right to alter, amend or terminate the Promotion or any aspect of it (including the Rules and Bonuses) at any time and without prior notice.

19. A Bonus cannot be combined with any other promotions that IG offers.
20. We will not be held liable for any losses incurred by you as a result of trading or in relation to this Promotion. We will not be held liable for your inability to satisfy the eligibility requirements of the Promotion or ability to trade as the result of any technical malfunction of the Internet, IG's trading platform, or your own computing system. You accept all risks associated with trading over the internet, mobile applications, and downloadable software.
22. Any dispute or situation not covered by these Rules, will be resolved by IG's management in a manner it deems to be fairest to all concerned and that decision will be final and binding on all parties.
23. If at any time all or any part of any provision of these Rules are or become illegal, invalid or unenforceable in any respect under the law of any jurisdiction, such provision(s) will not affect or impair the legality, validity or enforceability in that jurisdiction of the remainder of that provision or all other provisions of these Rules or the legality, validity or enforceability under the law of any other jurisdiction of that provision or all other provisions of these Rules.
24. If any tax is payable on a Bonus paid by us to you pursuant to the Rules, this tax will be your liability and will not be incurred by us. If the law requires us to withhold this tax and settle with the relevant tax authority on your behalf, then we shall credit the Bonus to your account net of this tax.
25. These Rules will be governed by and construed in accordance with the laws of the State of Illinois and will be subject to the jurisdiction of the courts of Cook County, Illinois.
