

Terms and Conditions

IG \$2.50 Share Trading Promotion

1. These terms and conditions (the 'Terms and Conditions') apply to the IG \$2.50 Share Trading Promotion (the 'Promotion'). By participating in the Promotion, you agree to be bound by these Terms and Conditions as set out herein.
2. The Promotional period commences 1 July 2022 and concludes at 11.59pm on 31 August 2022.
3. You must be a new client to IG or not have any existing share trading account(s) with us.

5. New share trading accounts opened during the months of July and August will have access to \$2.50 commission (or 0.05%, whichever is higher) on Australian shares, from the date of the individual account opening to 11.59pm on 31 August 2022.
6. There is no minimum number of trades to obtain the \$2.50 commission rate during the Promotion period.
7. At the end of the Promotion period, commissions revert back to standard rates. Other fees and charges may apply.
8. This Promotion is only available to clients who opt for the default setting of 'instant currency conversion'.
