



IG US New Account Bonus Terms and Conditions

1. These terms and conditions (“Rules”) apply to the New Account Bonus promotion (“Promotion”), which begins **August 1st, 2022** (“Start Date”) and expires **June 1, 2023, at 11:59pm ET** (“Expiration Date”). By participating in the Promotion, you agree to be bound by these Terms and Conditions, as well as any other terms applicable to your account, which are hereby incorporated by reference, including but not limited to the IG Customer Agreement (<https://www.ig.com/us/customer-agreement>) and the IG Website Terms and Conditions (<https://www.ig.com/us/site-terms-and-conditions>). IG’s computer is the official clock for the Promotion.

How to participate

2. To be eligible to participate in the Promotion, the person claiming the bonus (“you,” “your”) must, as of the date you sign up for the Promotion:
 - a. Not hold an existing personal, joint, or legal entity forex trading account with IG US LLC (“IG,” “us,” or “our”), a Commodity Futures Trading Commission (CFTC) registered retail foreign exchange dealer and member of the National Futures Association (“NFA”) (NFA #0509630) with its primary address: 1000 West Fulton Street, Chicago, IL 60607 and contact details: 1-312-981-0500 and helpdesk.us@ig.com (“we”, “us”, “IG” or “our”);
 - b. Be an individual who is 18 years or older, and not barred from accessing our service under applicable law;
 - c. Be a legal resident of the United States (excluding residents of Ohio); and
 - d. Conduct and execute trades that are confirmed by IG on our platform.
3. To participate in the Promotion and be eligible for a Bonus, you must:
 - a. Be approved for an IG account and complete all required documentation and identity checks;
 - b. Open and fund a new active personal forex trading account with us (a “Qualifying Account”) through the Promotion URL provided by us; and
 - c. Meet the requirements for either the Standard Bonus or the Premium Bonus as set forth in these Rules prior to the Expiration Date.

Failure to sign-up for a new account using the correct URL will disqualify you from participating in the Promotion.

Standard Bonus

4. A New Account Standard Bonus (“Standard Bonus”) of \$250 USD will be paid into a Qualifying Account that has made a first deposit of at least five hundred dollars (\$500 USD) and executed at least one opening trade after the Start Date and prior to the Expiration Date.

Premium Bonuses

5. A New Account Premium Bonus (“Premium Bonus”) of \$1,000 USD will be paid into a

Qualifying Account that has completed a first deposit of at least \$5,000 USD and executed opening trades that total at least 100 standard contracts, or lots, after the Start Date and prior to the Expiration Date. These trades can be in any currency pairs offered by IG.

6. An Account Premium Bonus (“Second Premium Bonus”) of \$5,000 will be paid into a Qualifying Account that has completed a first deposit of at least \$50,000 and executed opening trades that total at least 300 standard contracts, or lots, after the Start Date and prior to the Expiration Date. These trades can be in any currency pairs offered by IG.

Terms Applicable to the Both Standard Bonus and Premium Bonuses

7. The Standard Bonus and Premium Bonuses are each a “Bonus” and collectively the “Bonuses.” Only one Bonus (Standard or Premium) will be paid per person. All deposits are subject to our review, approval, and discretion.
8. When depositing from a debit card for the first time, for verification purposes, a micro deposit of \$1.00 USD will be credited to your IG account. This micro deposit is **not** the minimum deposit amount required for purposes of this Promotion, nor is it counted towards your initial deposit. The minimum deposit amount required to qualify for the Promotion will be reflected on the deposit funds screen in your IG account.
9. For the purposes of calculating the required trade volume, only opening trades that have been executed and confirmed by IG will count towards the total. Unexecuted or rejected trades will not count, nor will closing trades.
10. Bonuses will be paid within approximately 45 days after completing all requirements for either the Standard Bonus or the Premium Bonuses.
11. If any restrictions apply to your account, the account will not qualify for a Bonus until the restrictions have been lifted. Any restrictions that apply to an account will be detailed in the email to you upon account activation. The account will not qualify for a Bonus if your account is closed for any reason prior to a Bonus being paid.
12. All accounts are subject to our standard account opening criteria and are subject to certain jurisdictional restrictions; therefore, not all applicants will be successful in their application for an account.
13. Joint accounts or accounts which have a Power of Attorney in force will not be eligible for a Bonus.
14. In the event your first deposit is cancelled, clawed, or charged back, returned from the bank for insufficient funds, fraud, or any other reason, you will become ineligible for a Bonus and IG has the right to reclaim and remove from your account any Bonus made to your account under this Promotion. In the event the removal of any Bonus paid to your account would result in a negative balance, the deficit amount may be submitted to IG’s third party collection agency.
15. The Promotion is not open to employees of IG or any IG group company, or employees of any other company engaged in direct competition with IG or any IG group company.

16. The Promotion and any obligations of IG pursuant to it will be revoked or withdrawn from participants who abuse the spirit or intention of it. We reserve the right to cancel or withdraw the Promotion at any time in case of any suspected abuse of the Promotion. Further, where any of these Rules are breached, if we believe that any of the terms of your Customer Agreement with us have been breached in any way, or there is any reason to suspect a participant has acted fraudulently or obtained an unfair or unintended advantage pursuant to this Promotion, we reserve the right to stop, withhold or cancel payment of a Bonus or to prevent any attempted withdrawal of the same from your account.
17. We are the sole arbiter of the Promotion, these Rules, and any other issues arising under this Promotion. Exceptions to these Rules are at the sole discretion of IG's management, and our decision is final. We reserve the right to alter, amend, or substitute the Bonus offered with another item of the same value, or terminate the Promotion or any aspect of it (including the Rules and Bonuses) at any time and without prior notice.
18. The Promotion offer is not transferable, saleable, or valid in combination with other offers.
19. We will not be held liable for any losses incurred by you as a result of trading or in relation to this Promotion. TRADING FOREIGN EXCHANGE ON MARGIN CARRIES A HIGH LEVEL OF RISK, and may not be suitable for all investors. Before deciding to trade foreign exchange, you should carefully consider your investment objectives, level of experience, and risk appetite. By participating in the Promotion, you agree to release, discharge, indemnify and hold harmless IG, its parent, subsidiaries, affiliates, advertising and promotion agencies, and all of their respective officers, directors, members, managers, partners, shareholders, employees and agents (collectively, "Released Parties") from any liability or damages which may arise out of participation in the Promotion. All applicable federal, state, and local laws and regulations apply. The Released Parties will not be held liable for your inability to satisfy the eligibility requirements of the Promotion or ability to trade as the result of any technical malfunction of the Internet, IG's trading platform, or your own computing system, nor will we liable for any lost/delayed data transmission, omission, interruption, deletion, defect, line failures of any telephone network, computer equipment, software, or any other error or malfunction, or any injury or damage to you or any other person's computer related to or resulting from participation in the Promotion. You accept all risks associated with trading over the internet, mobile applications, and downloadable software.
21. Any dispute or situation not covered by these Rules will be resolved by IG's management in a manner it deems to be fairest to all concerned, and that decision will be final and binding on all parties.
22. If at any time all or any part of any provision of these Rules are or become illegal, invalid, or unenforceable in any respect under the law of any jurisdiction, such provision(s) will not affect or impair the legality, validity, or enforceability in that jurisdiction of the remainder of that provision or all other provisions of these Rules or the legality, validity, or enforceability under the law of any other jurisdiction of that provision or all other provisions of these Rules.
23. If any tax is payable on a Bonus paid by us to you pursuant to the Rules, this tax will be your liability and will not be incurred by us. If the law requires us to withhold this tax and settle with the relevant tax authority on your behalf, then we shall credit the Bonus to your account

net of this tax.

24. These Rules will be governed by and construed in accordance with the laws of the State of Illinois and will be subject to the jurisdiction of the courts of Cook County, Illinois, without giving effect to any choice of law or conflict of law rules (whether of the State of Illinois, or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than in the State of Illinois.
