



IG US New Account Bonus Updated Terms and Conditions

1. These updated terms and conditions (“Rules”) apply to the New Account Bonus promotion (“Promotion”), which began on **March 1st, 2023** (“Start Date”) and expires **Feb 1st, 2024, at 11:59pm ET** (“Expiration Date”), and shall apply from and after March 1, 2023 (the “Effective Date”) and replace the terms and conditions of the Promotion in effect as of the Start Date (the “Prior Rules”), from and after the Effective Date for any new account opened on or after the Effective Date. By participating in the Promotion, you agree to be bound by these Rules, as well as any other terms applicable to your account, which are hereby incorporated by reference, including but not limited to, the IG Customer Agreement (<https://www.ig.com/us/customer-agreement>) and the IG Website Terms and Conditions (<https://www.ig.com/us/site-terms-andconditions>). The time set forth in IG’s computer is the official clock for the Promotion.

How to participate

2. To be eligible to participate in the Promotion, the person claiming the bonus (“you” or “your”) must, as of the date you sign up for the Promotion:
 - a. Not hold an existing personal, joint, or legal entity forex trading account with IG US LLC (“IG,” “us,” or “our”), a Commodity Futures Trading Commission (CFTC) registered retail foreign exchange dealer and member of the National Futures Association (“NFA”) (NFA #0509630) with its primary address: 1330 West Fulton Street, Chicago, IL 60607 and contact details: 1-312-981-0500 and helpdesk.us@ig.com (“we”, “us”, “IG” or “our”);
 - b. Be an individual who is 18 years or older, and not barred from accessing our service under applicable law;
 - c. Be a legal resident of the United States (excluding residents of Ohio); and
 - d. Conduct and execute trades that are confirmed by IG on our platform.
3. To participate in the Promotion and be eligible for a Bonus, you must:
 - a. Be approved for an IG account and complete all required documentation and identity checks;
 - b. Open and fund a new active personal forex trading account with us (a “Qualifying Account”) through the Promotion URL provided by us; and
 - c. Meet the requirements for Premium Bonus 1 and/or Premium Bonus 2 as set forth in these Rules prior to the Expiration Date.

Failure to sign-up for a new account using the correct URL will disqualify you from participating in the Promotion or receiving any bonus (including Premium Bonus 1 or Premium Bonus 2).

Premium Bonuses

4. A New Account Premium Bonus (“Premium Bonus 1”) of \$1,000 USD will be paid into a

Qualifying Account that has funded an initial deposit of at least \$5,000 USD and executed opening trades that total at least 100 standard contracts, or lots, after the Start Date and prior to the Expiration Date. These trades can be in any currency pairs offered by IG.

6. In addition to Premium Bonus 1, an additional New Account Premium Bonus (“Premium Bonus 2”) of \$4,000 USD will be paid into a Qualifying Account that has funded an initial deposit of at least \$50,000 USD and executed opening trades that total at least 300 standard contracts, or lots, after the Start Date and prior to the Expiration Date. These trades can be in any currency pairs offered by IG. For the avoidance of doubt, any person qualifying for Premium Bonus 2 will receive an aggregate of \$5,000 USD pursuant to this Promotion.

Terms Applicable to Premium Bonus 1 and Premium Bonus 2

7. Premium Bonus 1 and Premium Bonus 2 are each referred to as a “Bonus” and collectively the “Bonuses.” All deposits are subject to our review, approval, and discretion.
8. When depositing from a debit card for the first time, for verification purposes, a micro deposit of \$1.00 USD will be credited to your IG account. This micro deposit is **not** the minimum deposit amount required for purposes of this Promotion, nor is it counted towards the funding of your initial deposit. The minimum deposit amount required to qualify for the Promotion will be reflected on the deposit funds screen in your IG account.
9. For the purposes of calculating the required trade volume, only opening trades that have been executed and confirmed by IG will count towards the total trades. Unexecuted or rejected trades will not count, nor will closing trades.
10. Bonuses will be funded to the Qualifying Account within approximately 45 days after the satisfaction of all requirements for such Bonus..
11. If any restrictions apply to your account, the account will not qualify for a Bonus until the restrictions have been lifted. Any restrictions that apply to an account will be detailed in the email to you upon account activation. The account will not qualify for a Bonus if your account is closed for any reason prior to a Bonus being funded into the account.
12. All accounts are subject to our standard account opening criteria and are subject to certain jurisdictional restrictions; therefore, not all applicants will be successful in their application for an account.
13. Joint accounts or accounts which have a Power of Attorney in force will not be eligible for a Bonus and are not Qualifying Accounts.
14. In the event your first deposit is cancelled, clawed, or charged back, returned from the bank for insufficient funds, fraud, or any other reason, you will become ineligible for a Bonus and IG has the right to reclaim and remove from your account any Bonus made to your account under this Promotion. In the event the removal of any Bonus paid to your account would result in a negative balance, the deficit amount may be submitted to IG’s third party collection agency.
15. The Promotion is not open to employees of IG or any IG group company, or employees of any other company engaged in direct competition with IG or any IG group company.

16. The Promotion and any obligations of IG pursuant to the Promotion will be revoked or withdrawn from participants who abuse the spirit or intention of the Promotion . We reserve the right to cancel or withdraw the Promotion at any time in case of any suspected abuse of the Promotion. Further, where any of these Rules are breached, if we believe that any of the terms of your Customer Agreement with us have been breached in any way, or there is any reason to suspect a participant has acted fraudulently or obtained an unfair or unintended advantage pursuant to this Promotion, we reserve the right to stop, withhold or cancel payment of a Bonus or to prevent any attempted withdrawal of the same from your account.
17. We are the sole arbiter of the Promotion, these Rules, and any other issues arising under this Promotion. Exceptions to these Rules are at the sole discretion of IG’s management, and our decision is final. We reserve the right to alter, amend, or substitute the Bonus offered with another item of the same value, or terminate the Promotion or any aspect of it (including the Rules and Bonuses) at any time and without prior notice.
18. The Promotion offer is not assignable, transferable, saleable, or valid in combination with any other offer and any purported assignment in violation hereof is void and of no effect.
19. We will not be held liable for any losses incurred by you as a result of trading or in relation to this Promotion. TRADING FOREIGN EXCHANGE ON MARGIN CARRIES A HIGH LEVEL OF RISK, and may not be suitable for all investors. Before deciding to trade foreign exchange, you should carefully consider your investment objectives, level of experience, and risk appetite. Such trading could result in a loss of some or all of the initial investment, and nobody should invest money that he or she cannot afford to lose.
20. This Promotion is conducted in English. By participating in the Promotion, you agree to release, discharge, indemnify and hold harmless IG, its parent, subsidiaries, affiliates, advertising and promotion agencies, and all of their respective officers, directors, members, managers, partners, shareholders, employees and agents (collectively, “Released Parties”) from any liability or damages which may arise out of, relate to or result from your participation in the Promotion. All applicable federal, state, and local laws and regulations apply. The Released Parties will not be held liable for your inability to satisfy the eligibility requirements of the Promotion or ability to trade as the result of any technical malfunction of the internet, IG’s trading platform, or your own computing system, nor will we liable for any lost/delayed data transmission, omission, interruption, deletion, defect, line failures of any telephone network, computer equipment, software, or any other error or malfunction, or any injury or damage to you or any other person’s computer arising out of, related to or resulting from participation in the Promotion. You accept all risks associated with trading over the internet, mobile applications, and downloadable software.
21. Any dispute or situation not covered by these Rules will be resolved by IG’s management in a manner it deems to be fairest to all concerned, and that decision will be final and binding on all parties.
22. If at any time all or any part of any provision of these Rules are or become illegal, invalid, or unenforceable in any respect under the law of any jurisdiction, such provision(s) will not affect or impair the legality, validity, or enforceability in that jurisdiction of the remainder of that provision or all other provisions of these Rules or the legality, validity, or enforceability under the law of any other jurisdiction of that provision or all other provisions of these Rules.

23. If any tax is payable on a Bonus paid by us to you pursuant to the Rules, this tax will be your liability and will not be incurred by us. If the law requires us to withhold this tax and settle with the relevant tax authority on your behalf, then we shall credit the Bonus to your account net of this withholding obligation and tax.
24. These Rules will be governed by and construed in accordance with the laws of the State of Illinois and will be subject to the jurisdiction of the courts of Cook County, Illinois, without giving effect to any choice of law or conflict of law rules (whether of the State of Illinois, or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than in the State of Illinois.

26. For the avoidance of doubt, the "Standard Bonus" under the Prior Rules shall no longer be in effect or apply to any account open on or after the Effective Date.
