

TERMS AND CONDITIONS: 2025 Premier League Season Finale Lucky Draw New User Promotion

1. These terms and conditions (the **"Terms and Conditions"**) apply to the promotion set out in Clause 3 below (the **"Promotion"**). By participating in the Promotion, participants agree to be bound by these Terms and Conditions. All capitalised but undefined terms herein shall be deemed to have the same meaning given to such terms in your Customer Agreement.
2. The Promotion is organised by IG Asia Pte Ltd (Co. Reg. No. 200510021K) with its registered address being #01-02 MYP Centre, 9 Battery Road, Singapore 049910 (**"IG"**).
3. The Promotion provides a chance to win a pair of Premier League tickets (**"Lucky Draw"**) for clients who open new accounts and trade with IG, subject to the Terms and Conditions set out below.

ELIGIBILITY TO PARTICIPATE IN THE LUCKY DRAW

4. To be eligible to take part in the Lucky Draw promotion you must satisfy the following terms (**"Lucky Draw Participant"**):
 - (a) you must apply to open an IG CFD account (your **"Account"**) on www.ig.com/sg between (and including) 00:00 SGT, 2nd January 2025 and 23:59 SGT, 28th February 2025 (the **"Campaign Period"**) and proceed to successfully open such account following successful completion of the 'customer knowledge assessment' procedure;
 - (b) the address submitted for the account opening application must be an address in Singapore;
 - (c) you must not have an existing Account with IG;
 - (d) you must not be a participant or have accepted any other promotions offered currently or previously by IG, save for the "IG's KrisFlyer Loyalty Programme" or "IG's Welcome Bonus Promotion", or otherwise as specified by IG;
 - (e) you must be a Singapore resident (i.e. you must either be a Singapore citizen, Singapore Permanent resident or have a valid and current Singapore employment or work pass issued by the Ministry of Manpower); and
 - (f) you must not be an employee (or any relation or partner or agent of an employee) of IG or any entity of IG Group.

LUCKY DRAW DETAILS

5. Only Accounts and Transactions that meet the eligibility criteria set out in these Terms will be allowed to enter the Lucky Draw.

6. The Promotion entitles a Lucky Draw Participant to receive 1 Lucky Draw chance after satisfying the Qualifying Trades criteria set out below during the Campaign Period. See table below for further information on the criteria to enter the Lucky Draw.

7. A ‘Qualifying Trade’ is a CFD transaction on which you have paid commission (subject to any applicable promotional offers) during the Campaign Period. For the avoidance of doubt, trades subject to a commission free period will not be considered a ‘Qualifying Trade’. The Transaction(s) must be initiated by you and not by IG acting on your behalf (e.g. system generated trades).
8. Lucky Draw Participants who satisfy the Qualifying Trades criteria set in clause 6 will be entered into the Lucky Draw, and 1 winner will be selected. The winner will be drawn by staff of IG at random with an external auditor as witness on 5 March 2025 (the “**Lucky Draw Date**”).
9. The winner will receive the following prizes:
- (a) 1x pair of Premier League tickets to watch the Liverpool vs Crystal Palace season finale match on 25th May 2025, with the Centenary Club hospitality package;
 - (b) 4-night stay at Hotel Municipal et Spa Liverpool – MGallery, Standard room with Breakfast, Check-in on 22nd May 2025 and Check-out on 26th May 2025; and
 - (c) SGD 5,000 flight tickets reimbursement with Commonwealth Travel Service Corporation Pte Ltd.
10. You must be fully authorised to operate your Account, and you can only enter with a maximum of 1 Lucky Draw Chance in this Promotion.
11. The winner will be contacted via email within 7 days from the Lucky Draw Date and has to redeem the prize by 14th March 2025 at the IG Asia Pte Ltd office. The prize will be forfeited if the winner does not respond or be uncontactable within 7 days from the Lucky Draw Date or fails to collect the prize by 14th March 2025. IG reserves the right to decide on one (1) or more reserve winner to replace the disqualified or forfeited winner. IG has the absolute discretion to exclude any otherwise eligible participating in the Lucky Draw.
12. The winner must provide consent to have their name and photos published on IG social media channels. The winner must also take at least 3 photos of themselves at the Liverpool vs Crystal Palace season finale match that IG can use on its social media channels.

13. The winner will be announced on IG's social media channels (Facebook and Instagram) on 5 March 2025.
14. The winner must book their flight with Commonwealth Travel Service Corporation Pte Ltd by 13 April 2025. IG will reimburse up to SGD 5,000 worth of flight tickets. Any additional costs and expenses incurred will be borne by the winner.
15. Prizes are non-transferable, and no cash alternatives are available.

OTHER DETAILS

16. We are the sole arbiter of the Lucky Draw promotion, these Terms and any other issues arising under the Lucky Draw promotion. We reserve the right, in our sole discretion, to (i) preclude you from participating in the Lucky Draw promotion; and/or (ii) alter, amend or terminate the Lucky Draw promotion or any aspect of it at any time and without prior notice, either as a whole or in relation to you only. If we make any changes to these Terms, we may notify you of such changes by posting the modified terms on our website. By continuing to trade us, you will be deemed to have accepted any such modified terms.
17. Unless otherwise stated in these Terms, all dates are determined in accordance with Singapore time.
18. We will not be liable for any losses incurred by you as a result of your trading in relation to this Lucky Draw promotion. Trading CFDs is a high-risk activity, and it is possible to lose more than your initial investment.
19. Any dispute or situation not covered by these Terms will be resolved by our management in a manner it deems to be fairest to all concerned and that decision shall be final and binding on all parties. We reserve the right to refuse to pay out or to credit to your account under the Lucky Draw promotion if (i) we have reasonable belief that the Lucky Draw promotion is being abused in any way (including any form of manipulation of transactions); (ii) we believe that the terms of the Customer Agreement have been breached in any way; and/or (iii) we have suspended or closed your account in accordance with the provisions of the Customer Agreement. We will not have any obligation to any person in terms of this Lucky Draw promotion if such person, in our sole opinion, abuses the spirit or intention of the Lucky Draw promotion.
20. If, at any time, all or any part of any provision of these Terms are or become illegal, invalid or unenforceable in any respect under the law of any jurisdiction, such provision(s) shall not affect or impair the legality, validity or enforceability in that jurisdiction of the remainder of that provision or all other provisions of these Terms or the legality, validity or enforceability under the

law of any other jurisdiction of that provision or all other provisions of these Terms.

21. Each person who participates or attempts to participate in the Lucky Draw promotion agrees that IG may disclose personal information in accordance with IG's Privacy and Access Policy. For the avoidance of doubt, each such person consents to IG exchanging, using and disclosing their personal information (including their name, address and date of birth) for the purposes of facilitating their participation or attempted participation in this Lucky Draw promotion.
22. These Terms shall be governed by and construed in accordance with the laws of Singapore and shall be subject to the jurisdiction of the Singaporean courts.

DEFINITIONS AND INTERPRETATION

23. In these Terms:

"Customer Agreement" means the agreement made between IG and you, governing the basis on which IG provides services to you and the dealings between IG and you.

"IG's KrisFlyer Loyalty Programme" means the programme maintained by IG where IG clients can accrue KrisFlyer miles when they open transactions on IG's trading platform.

"IG's Welcome Bonus Promotion" means the programme maintained by IG where new IG clients can get rewarded with a Welcome Bonus when they open transactions on IG's trading platform.
