

## TERMS AND CONDITIONS: Rolex Lucky Draw 2025

1. These terms and conditions (the **"Terms and Conditions"**) apply to the promotion set out in Clause 3 below (the **"Promotion"**). By participating in the Promotion, participants agree to be bound by these Terms and Conditions. All capitalised but undefined terms herein shall be deemed to have the same meaning given to such terms in your Customer Agreement.
2. The Promotion is organised by IG Asia Pte Ltd (Co. Reg. No. 200510021K) with its registered address being #27-01 Singapore Land Tower, 50 Raffles Place, Singapore 048623 (**"IG"**).
3. This Promotion provides a chance for all eligible Participants (as defined in Clause 4 below) to take part in lucky draw (**"Rolex Lucky Draw 2025"**) where each eligible Participant stands a chance to win a Rolex Submariner Date (**"Prize"**) for each lucky draw.

### ELIGIBILITY TO PARTICIPATE IN THE ROLEX LUCKY DRAW 2025

4. To be an eligible participant to take part in the Rolex Lucky Draw 2025 promotion you must satisfy the following terms (**"Participant"**):
  - (a) hold an IG CFD account (your **"Account"**);
  - (b) execute Qualifying Trade(s) (as defined below) between 00:00 SGT, 1<sup>st</sup> December 2025 and 23:59 SGT, 31<sup>st</sup> December 2025 (**"Qualifying Period"**);
  - (c) you must be a Singapore resident (i.e. you must either be a Singapore citizen, Singapore Permanent resident or have a valid and current Singapore employment or work pass issued by the Ministry of Manpower); and
  - (d) you must not be an employee (or any relation or partner or agent of an employee) of IG or any entity of IG Group.

### ROLEX LUCKY DRAW 2025 Details

5. Participants will earn one (1) entry into the Rolex Lucky Draw for every US\$1,000,000 notional value of the opening Transaction for each Qualifying Trade during the Qualifying Period (**"Entry"**).
6. Each Participant is limited to a maximum of fifty (50) Entries.
7. A 'Qualifying Trade' is a CFD transaction on which you have paid commission or spread (subject to any applicable promotional offers) on opening a transaction during the Qualifying Period. For the avoidance of doubt, closing a transaction is not considered a 'Qualifying Trade' and trades subject to a commission free period will also not be considered a 'Qualifying Trade'. The Transaction(s) must be initiated by you and not by IG acting on your behalf (e.g. system generated trades).

8. The notional value for each Qualifying Trade will be calculated based on the notional value of the opening transaction and not the notional value of the closing transaction.
9. Participants who satisfy all the criteria in Clause 4 will be entered into the Rolex Lucky Draw 2025 where a total of one (1) lucky draw will be made to determine the winner of the Prize. Lucky draw will select one (1) winner to receive a Rolex Submariner Date . The winners will be drawn by staff of IG with an external auditor as witness on 8 January 2026 (the **"Lucky Draw Date"**).
- 10.If you have more than one account, only one account will be eligible for the Rolex Lucky Draw 2025
- 11.You must be fully authorised to operate your Account.
- 12.The winner(s) will be contacted via email within 7 days from the Lucky Draw Date and has to redeem the Prize(s) by 1 February 2026 at IG Asia Pte Ltd's office. The Prize will be forfeited if the winner does not respond or be contactable within 7 days from the Lucky Draw Date or fails to collect the prize by 1 February 2026. IG reserves the right to decide on one (1) or more reserve winner to replace the disqualified or forfeited winners.
- 13.IG has the absolute discretion to exclude any eligible Participant in the Rolex Lucky Draw 2025 if there is any suspicion of fraud.
- 14.The winners consent to have their name and photos of themselves receiving the prize to be published on IG Singapore's social media channels.
- 15.IG reserves the right to (i) select the colour of the Prize; (ii) substitute the Prize with an alternative reward of equivalent value; and (iii) Prizes are non-transferable.

## OTHER DETAILS

- 16.We are the sole arbiter of the Rolex Lucky Draw 2025 promotion, these Terms and any other issues arising under the Rolex Lucky Draw 2025 promotion. We reserve the right, in our sole discretion, to (i) preclude you from participating in the Rolex Lucky Draw 2025 promotion; and/or (ii) alter, amend or terminate the Rolex Lucky Draw 2025 promotion or any aspect of it at any time and without prior notice, either as a whole or in relation to you only. If we make any changes to these Terms, we may notify you of such changes by posting the modified terms on our website. By continuing to trade us, you will be deemed to have accepted any such modified terms.

17. Unless otherwise stated in these Terms, all dates and times are determined in accordance with Singapore time.
18. We will not be liable for any losses incurred by you as a result of your trading with IG, including but not limited to, in relation to this Rolex Lucky Draw 2025. Trading CFDs is a high-risk activity, and it is possible to lose more than your initial investment.
19. Any dispute or situation not covered by these Terms will be resolved by our management in a manner it deems to be fairest to all concerned and that decision shall be final and binding on all parties. We reserve the right to refuse to pay out or to credit to your account under the Rolex Lucky Draw 2025 if (i) we have reasonable belief that the Rolex Lucky Draw 2025 promotion is being abused in any way (including any form of manipulation of transactions); (ii) we believe that the terms of the Customer Agreement have been breached in any way; and/or (iii) we have suspended or closed your account in accordance with the provisions of the Customer Agreement. We will not have any obligation to any person in terms of this Rolex Lucky Draw 2025 promotion if such person, in our sole opinion, abuses the spirit or intention of the Rolex Lucky Draw 2025 promotion.
20. If, at any time, all or any part of any provision of these Terms are or become illegal, invalid or unenforceable in any respect under the law of any jurisdiction, such provision(s) shall not affect or impair the legality, validity or enforceability in that jurisdiction of the remainder of that provision or all other provisions of these Terms or the legality, validity or enforceability under the law of any other jurisdiction of that provision or all other provisions of these Terms.
21. Each person who participates or attempts to participate in the Rolex Lucky Draw 2025 promotion agrees that IG may disclose personal information in accordance with IG's Privacy and Access Policy. For the avoidance of doubt, each such person consents to IG exchanging, using and disclosing their personal information (including their name, address and date of birth) for the purposes of facilitating their participation or attempted participation in this Rolex Lucky Draw 2025 promotion.
22. These Terms shall be governed by and construed in accordance with the laws of Singapore and shall be subject to the jurisdiction of the courts of Singapore.

## DEFINITIONS AND INTERPRETATION

23. In these Terms:

**"Customer Agreement"** means the agreement made between IG and you, governing the basis on which IG provides services to you and the dealings between IG and you.
