## IG Australia Pty Ltd - Refer a Friend Bonus Terms and Conditions

- These terms and conditions ("Terms and Conditions") apply to the Refer a Friend bonus promotion ("Bonus Promotion"). By participating in this Bonus Promotion, you agree to be bound by these Terms and Conditions. All capitalised but undefined terms herein shall be deemed to have the same meaning given to such terms in your Customer Agreement.

- 3. This Bonus Promotion provides a Refer a Friend Reward (as set out in Term 8 below), subject to the Terms and Conditions set out below.

## **Eligibility for Refer a Friend Bonus**

- 4. To be eligible to take part in the Bonus Promotion, you must satisfy the following terms:
  - a. you must hold an active share trading account with IG ; and
  - b. be an individual and a direct client of IG.

## Qualifying criteria for CFD Bonus and Share Trading Bonus

- 5. If you are eligible to take part in the Bonus Promotion, in order to qualify to receive the Refer a Friend Reward, the following terms must be satisfied:
