

IG Australia Pty Ltd - IG \$100 Share Trading Promotion Terms and Conditions

- 1. These terms and conditions (the 'Terms and Conditions') apply to the IG \$100 Share Trading Promotion (the 'Promotion'). By participating in the Promotion, you agree to be bound by these Terms and Conditions as set out herein.
- 2. The Promotion's period commences at 00:01 am on 7 October 2024 and concludes at 11:59 pm on 30 Nov 2024 (the 'Promotional Period').
- 3. This Promotion is available exclusively to IG's select existing clients who have a valid share trading account with IG and received an email to their IG registered email address with the headline "Trade with IG by 30 November and get \$100 credit" as well as New Clients. 'New Clients' are defined as individuals who successfully open a new share trading account with IG within the Promotional Period. For the avoidance of doubt, this Promotion is not open to existing clients who did not receive the above-mentioned email to their IG registered email address.
- 4. This Promotion is only made available to individuals and is not applicable to companies or trusts.
- 5. To be eligible for the \$100 to be credited in your share trading account with IG, you must complete five (5) Qualifying Trades within the Promotional Period. A 'Qualifying Trade' is defined as one (1) open position or one (1) closed position, each constituting a separate trade. Each qualifying trade is required to have a minimum total order size of AUD\$500, excluding any commission paid.
- 6. The \$100 credit will be paid to eligible share trading accounts within 45 days after the promotion period ends (by 14 Jan 2025).
- 7. This Promotion is only available to clients who opt for the default setting of 'instant currency conversion'.
- 8. If you have more than one account with IG, only one account can be eligible for this credit. If you already have a share trading account with IG and have not received our email invitation, you will not be eligible to participate in this promotion by opening a new share trading account.

- 10. This Promotion is not open to employees of IG or any IG Group company, or employees of any other company engaged in direct competition with IG or any IG Group company.

- 12. IG is the sole arbiter of this Promotion and reserves the right, in its sole discretion, to modify, suspend, withdraw or terminate the Promotion (or part thereof) at any time without prior notice and without liability to you.
- 13. IG will not be held liable for any losses incurred by you as a result of your trading in relation to your account(s) with IG. All trading involves risk and you are responsible for managing your positions and exposure.
- 14. This Promotion and any obligations of IG pursuant to it will be revoked or withdrawn from participants who abuse the spirit or intention of it. We reserve the right to cancel or withdraw the Promotion at any time in case of any suspected abuse of this Promotion. Further, where any of these Terms and Conditions are breached, if we believe that any of the terms of your Customer Agreement with us have been breached in any way, you no longer have an account with IG or there is any reason to suspect a participant has acted fraudulently or obtained an unfair or unintended advantage pursuant to this Promotion, we reserve the right to immediately stop the benefits of this Promotion.

If, at any time all, or any part of any provision of these Terms and Conditions are or become illegal, invalid or unenforceable in any respect under the law of any jurisdiction, such provision(s) shall not affect or impair the legality, validity or enforceability in that jurisdiction of the remainder of that provision or all other provisions of these Rules or the legality, validity or enforceability under the law of any other jurisdiction of that provision or all other provisions of these Terms and Conditions.
- 16. These Terms and Conditions shall be governed by and interpreted in accordance with the laws of the State of Victoria. The Courts of Victoria shall have exclusive jurisdiction over any disputes arising from these Terms and Conditions, including the validity and enforceability thereof.
