

TERMS AND CONDITIONS: SHARE YOUR BEST PLATFORM TIP ACTIVITY

- 1. These terms and conditions (the 'Rules') apply to the Share Your Best Platform Tip Activity set out in the IG Community (the 'Promotion'). By participating in the Promotion, participants agree to be bound by these Rules. All capitalised but undefined terms herein shall be deemed to have the same meaning as given to such terms in your Customer Agreement.

 - (a) England and Wales and shall by subject to the exclusive jurisdiction of the English courts, for Qualifying Participants holding an account with IG Markets Limited and/or IG Index Limited; and
 - (b) Republic of Singapore and shall be subject to the exclusive jurisdiction of the Singapore courts, for Qualifying Participants holding an account with IG Asia Pte Ltd.
